



An agreement to structure capital made available through
Triple E's www.yourgoodnature.com

between

Triple E

and

Name NGO

Parties,

1. [name NGO/organization], officially residing in [city], [country], and hereby represented by [name] hereafter referred to as [?],

and
2. Triple E B.V., officially residing in Arnhem (the Netherlands), and hereby represented by its director Tom Bade, hereafter referred to as Triple E.

Take into account

- [name NGO/organization] will be included in the database and website of www.yourgoodnature.com, thereby expanding its reach to potential donors.
- [name NGO/organization] hereby commits that money received for any projects, equipment, biodiversity or landscape elements through www.yourgoodnature.com has to be spent on that respective item, and that item only.
- This contract is a legally binding agreement between Triple E and [name NGO/organization] to utilize the capital made available for any respective project, equipment or biodiversity or landscape element to solely use this capital for this purpose.
- This agreement has six (6) pages.

Definition:

Service or product: projects, equipment, biodiversity or landscape elements, or other services that [name NGO/organization] has placed on www.yourgoodnature.com which are at present facing a lack of capital in order to obtain its objectives.

Triple E and [name NGO/organization] have agreed as follows:

Article 1. Objective

1.1 The objective of this agreement is to provide a legally binding structure how to deal with capital that has been made available for services or products (projects, equipment, biodiversity or landscape elements, or other services) that [name NGO/organization] has put on the website of www.yourgoodnature.com, as well as how to deal with any related matters.

Article 2. Bank account

2.1 Triple E has initiated a bank account through which all transactions occur that are related to www.yourgoodnature.com. [name NGO/organization] provides all the necessary details of its bank account to Triple E, in order for Triple E to channel the capital that has been made available by donors through the website to [name NGO/organization] .

2.2 [name NGO/organization] appoints one responsible person within the organization that acts as the contact person towards Triple E concerning any transactions through www.yourgoodnature.com. This person is the director or any other senior member of staff with decision powers over the budget of [name NGO/organization] .

Article 3. Payment

3.1 After a donor has financially supported a service or product of [name NGO/organization] on the website www.yourgoodnature.com and the money has been received by Triple E, Triple E will strive to channel these respective payments as quickly as possible to the designated bank account of [name NGO/organization] .

3.2 Triple E transfers the full amount of money (= donation minus the percentage that Triple E charges to cover its cost) that has been made available through www.yourgoodnature.com for the respective service or product of [name NGO/organization] , unless both parties have agreed otherwise.

3.3 Triple E will transfer the payments in the currency '€' (Euro). If [name NGO/organization] is situated in a country with a different currency, Triple E will use the exchange rate on the date of the transaction.

3.4 [name NGO/organization] is not entitled to receive the interest earned during the time the donation was on the www.yourgoodnature.com bank account.

Article 4. Use of capital by [name NGO/organization]

4.1 [name NGO/organization] is legally entitled by means of this contract to use the capital that has been received by Triple E solely (i.e. for 100%) for the specific service or product of [name NGO/organization] offered at www.yourgoodnature.com to finance this respective product or service. [name NGO/organization] is not entitled under any circumstance to use the money for other projects or other purposes.

Article 5. Price of product or service put on www.yourgoodnature.com by [name NGO/organization]

5.1 www.yourgoodnature.com is a website that is meant to generate an additional revenue stream to conservation organizations and other entities in need of capital. [name NGO/organization] , by signing this agreement, confirms that the price tag that has been attached to all the products or services (projects, equipment, biodiversity or landscape elements, or other services) represents the nominal or fair price to financially support the respective product(s) or service(s) for the intended project duration.

Article 6. Additionality

6.1 By agreeing to this contract [name NGO/organization] confirms that it has not received other funds or capital from other sources to support the products or services offered on www.yourgoodnature.com. In other words, the capital that [name NGO/organization] may receive for its respective products or services, is fully additional and unique.

6.2 In case [name NGO/organization] has, over the time that the respective product or service has been visible and available on www.yourgoodnature.com, already received capital for the respective service or product from another source other than www.yourgoodnature.com, Triple E will consult with the www.yourgoodnature.com donor, and with [name NGO/organization] how the money will be alternatively used. In the latter case, the donor has the possibility to choose for another organization and project on www.yourgoodnature.com.

6.3 [name NGO/organization] is legally required to inform Triple E if it has already received funds or capital to support the respective product or service for which it has received capital through www.yourgoodnature.com. The product or service will be removed and can be replaced by another service or element, as decided by [name NGO/organization] .

Article 7. Verification and monitoring

7.1 [name NGO/organization] understands that it is legally committed to use any funds or capital made available through www.yourgoodnature.com as stipulated in this contract (as defined in articles 4, 5, 6 and 8).

7.2 [name NGO/organization] will keep legible and detailed books of accounts and records relating to products or services involving www.yourgoodnature.com, its name and logo and shall allow representatives of Triple E to inspect, audit and take copies of any such books of accounts, and other records, as deemed necessary. www.yourgoodnature.com's accounts are available at any time, with advance notice.

7.3 Triple E stimulates donors, who have financially contributed to the conservation and preservation of the services and/or products of [name NGO/organization] , to visit the respective location in which the services are carried out, or where the product, the donor has

supported, is located. This ensures a kind of social control that Triple E envisions without too restrictive control mechanisms, as well as that it provides for a closer relationship between buyer (i.e. donor) and provider (i.e. [name NGO/organization]). In case a donor is interested to visit the project to which he/she has contributed, the respective conservation organization or landowner cooperates and allows donors to see for themselves how the project is doing for which they have contributed. All cost of this visit will be paid for by the donor, including cost of [name NGO/organization] . The visits will only occur when possible and after agreement from [name NGO/organization] .

7.4 Triple E provides donors with the opportunity to contact www.yourgoodnature.com when they are interested or have any questions relating the project(s) of [name NGO/organization] .

Article 8. Failing to comply with this agreement

8.1 If [name NGO/organization] fails to comply with this agreement, most notably to: 1) fully dedicate (for the full 100%) to use any capital made available through www.yourgoodnature.com to support only those respective products or services (projects, equipment, biodiversity or landscape elements, or other services) for which capital has been made available by a donor; 2) to provide a fair and nominal price for the elements it has placed on www.yourgoodnature.com; and 3) to be fully additional with respect to capital received for respective products or services [name NGO/organization] has placed on www.yourgoodnature.com, Triple E is legally entitled to take a number of steps that are highlighted in article 8.2.

8.2 In case [name NGO/organization] fails to comply with this agreement, Triple E is entitled to: 1) take back any payments for which [name NGO/organization] cannot show they have been rightly used; 2) block further payments to [name NGO/organization] if the organization has previously misspend any capital it has received through www.yourgoodnature.com; 3) be removed from the website of www.yourgoodnature.com. In this way Triple E ensures to only deal with trustworthy entities, to protect its corporate reputation and the reputation of www.yourgoodnature.com and the organizations participating in it, like [name NGO/organization] .

Article 9. Applicable law and competent court

9.1 All engagements between Triple E and [name NGO/organization] to which this agreement complies shall be subject to the laws of the Netherlands.

9.2 All disputes related to engagements between Triple E and [name NGO/organization] to which this agreement applies will be brought before the competent court in the district in which Triple E is resident, which shall have exclusive jurisdiction.

9.3 The above shall not affect the rights of the parties to agree to a different manner to settle disputes.



Article 10. Termination of contract

10.1 This agreement can be terminated at any time with four week's written notice on either side.
